A reasonable accommodation is something you need to happen or change so that you can take part in your:

- Job
- Place of learning
- Community



the same as other people.


It has nothing to do with having a nice place to stay, like a hotel.

A job support person




Someone who will help you with social situations at work



Someone who will ask if you are okay at work



Written information and instructions about your job.




Spoken information and instructions about your job.



Another way of communicating information and instructions about your job.



Someone to talk through information and instructions and check if you understand them



### Routine

Making sure your job is the same every day



## **Flexibility**

The option to make changes to your job day to day



A place to work near lots of people who can help you



A place to work by yourself



A place to work that is calm and quiet



Having important objects kept in the same place every time



Doing one task or job at the time



Having a recorder, voice organiser, or smart pen with a recorder to help you remember things



Wearing earplugs or headphones when it is safe to do so
